## Partial Amendments to the Articles of Incorporation

Japan, May 15, 2007 - Astellas Pharma Inc. (Headquarters: Tokyo; President and CEO: Masafumi Nogimori, hereinafter called the "Company") today announced that at the meeting of the Board of Directors held today the Company resolved that a proposal, "Partial Amendments to the Articles of Incorporation", will be submitted to the 2nd Ordinary General Meeting of Shareholders scheduled to be held on June 26, 2007.

#### **Particulars**

#### 1. Reason for Amendments:

The Company will establish new provisions regarding the effectiveness of the primary election of a substitute Corporate Auditor pursuant to Article 329, Paragraph 2 of the Corporate Law, in Article 33 of the Articles of Incorporation, thereby enabling the effectiveness of the primary election to continue before the start of the ordinary general meeting of shareholders relating to the last fiscal year that ends within four (4) years after their election. Articles after Article 33 shall be renumbered accordingly.

Details of the proposed amendments are as follows.
